### ARTIST'S INFORMATION PACKAGE

Dear Artist,

You are invited to participate in the 2022 Interlake Juried Art Show. This is an opportunity for Interlake Artists to enter their work into competition and to have their work adjudicated by Professional Artists from across Manitoba. There are two main entry levels - Adult and Youth - and the art is then separated into 12 different Categories. Participants will receive written critiques from the Jurors.

**The Show will be open to the public on Saturday April 30<sup>th</sup> from 10 am to 5 pm and again on Sunday May 1<sup>st</sup> from 10:00 to 2.00 pm. An Art Talk will be presented by the Jurors, Friday April 29<sup>th</sup> followed by an Artist's Reception from 6 to 8 pm. Please RVSP to the Reception on the Entry Form. Closing ceremony and awards presentation will be held on Sunday May 1<sup>st</sup> between 2 - 3 pm. Join us as we celebrate the work of our Interlake Artists at the 2022 Interlake Juried Art Show!**

**Uncategorized works will not be adjudicated. Jurors reserve the right to reassign artwork from one category to another; the juror's decision is final. See more info under Rules and Criteria.**

#### Entries:

- Adult - \$15.00 per entry
- Youth ages 13-17 - \$5.00 per entry
- Maximum of 6 entries per artist; limit of three in any one category.
- Youth wishing to be judged in the Adult category must pay the Adult fee of \$15.00 per entry.

## Deadline for submissions is **April 3<sup>rd</sup>, 2022.**

**Rules and Criteria:** - Work not meeting these conditions will not be accepted.

- Art must be finished, dry and ready to hang, with a wire affixed to the back to ensure that the artwork will hang on the display properly. **Serrated clips are not acceptable and will be rejected.**
- Artwork must be no more than 3 years old. Previous winning entries of any juried show are not eligible.
- Artwork must be original and not copied from other artists (copyright rules apply).
- Open to artists whose permanent address is located within the Interlake Region of Manitoba.
- All Artwork must be original, **commercial kits and patterns are not eligible.**
- Special instructions for hanging, if required must be provided. Should a special display be required, artist must supply it.
- Jurors reserve the right to reassign artwork from one category to another; the Juror's decision is final in all cases.
- Disqualification will result if the work submitted is not that indicated on the entry form.
- All artwork must have the supplied tags attached. Art with no tags will be disqualified.
- Registration money will not be refunded for work arriving late at the Recreational Complex or for "no shows".

### **Sales:**

Artists must clearly state whether artwork is for sale by marking the sale price on the entry form and on the information tag. Artists are responsible for their own sales. There will be no commission charged for any pieces sold at the Interlake Juried Art Show. If you are not present, your contact information will be shared with the prospective buyer.

### **Insurance:**

No individual or organization assumes responsibility for any loss, damage or injury to any entries and exhibits. The artist is responsible for insuring their work while in transit, while work is stored and on display. Artists should check with their home insurance agents to see if extra insurance is required.

### **Packaging:**

- The artist is responsible for packing works properly in a sturdy container. Do not pack with Styrofoam peanuts. *Place name, address, phone number, e-mail address, and the names and number of entries enclosed on the outside of the container.*
- Attach an Information Tag on the back of each piece of artwork. Information tags are provided as a separate attachment.
- **Due to limited space packing material from hand delivered works will not be stored during the show - the exception will be from the works picked up from the secondary depots.**
- Artwork dropped off at secondary depots must be able to be transportable by a van. **See drop off locations below.**

### **Shipping:**

- Shipping is not provided by the Interlake Juried Art Show. Please drop off your artwork at the locations indicated below.
- Secondary depots will be accepting art for transportation to the show site. Arrangements must be made by artist for pick up immediately following the show from The Selkirk Recreational Centre 180 Easton Drive, Selkirk, Manitoba on **Sunday May 1, between 3 pm and 4 pm.**
